NOTE: Total bed utilization on the 2013 was at 114%. The reason for this is that many programs had babies sleeping in cribs on the night of the HIC, and cribs were not part of the bed count. Also, Shelter Plus Care programs were able to enroll more clients in the program than the number of vouchers they were awarded due to families having some income at entry, so OCHA didn't have to pay the full rent amount.
